DELEJIS, S/o Late Mr. K. Chellan, aged about 27 years, residing at Kuzhiodel Vilai, Edaicode Post, Kanyakumari district as trustees of this Trust.

- b) The Trustees herein shall hold office at their pleasure until the vacation of office or otherwise.
- c) The trustees shall hold meetings from time to time as per necessity for considering matters connected with the Trust or its affairs or to enact any business of the Trust that may be held at any place as the trustees may desire.
- d) The Managing Trustee shall be the executive head of the Trust. He shall conduct and preside over all the meetings.
- e) The Managing Trustee has got full authority either to edit or reject or accept any resolution to be brought by the Trustees before the Trust Board.
- f) The Managing Trustee is empowered to include and appoint any other person as a Trustee of this Trust at any point of time.
- g) The Managing Trustee is empowered to appoint the office bearers who would be needed to manage the Trust.

11. PROMOTING AND CARRYING OUT THE OBJECTS:

- a) The Managing Trustee is empowered to apply for and receive contributions, donations and grants from Individuals, Institutions, Internal and External Agencies, State and Central Governments as the case may be.
- b) The Managing Trustee is empowered to purchase, lease or rent property as and when required to promote and execute the objects.
- c) The Managing Trustee is empowered to raise loans and such funds from Individuals, Banks, Financial institutions, and Government.

d) The Managing Trustee may enter into contract, or agreement or any other type of such transaction with Individuals or other agencies for the purposes of promoting the aims of the Trust.

e) The Managing Trustee is empowered to take on lease, license, hire, or otherwise required to hold, manage , administer, and deal with movable and immovable properties of the Trust.

f) The Managing Trustee is empowered to sell, alienate, mortgage, pledge, hypothecate, transfer, give rights, or otherwise deal with the properties, funds and assets of the Trust as he may feel fit.

g) The Managing Trustee is empowered to appoint persons, representatives, agents and such other persons in order to carry out the aims of the Trust.

h) The Trust Funds borrowed, acquired or earned shall be solely utilized towards fulfilling the objectives of the Trust and no portion of it shall be utilized for any other purpose.

12. DETERMINATION OF THE TRUST:

The Trust is at the will and pleasure of the Founder. He can terminate the operations of the Trust and take over the subject matter of the Trust at his hands and can make decisions as he desires for the better functioning of the Trust.

12. BANKING ACCOUNTS:

The Trust Board shall open one or more bank accounts in the name of the Trust. All income, subscriptions and pecuniary donations for the general

purpose of the trust and the income from investments and all other money received from time to time forming part of the general revenue of the Trust shall be paid into one or more banks. The banking account or accounts shall be opened and operated by the Managing Trustee individually.

13. ACCOUNT AND AUDIT:

The Founder and trustees shall keep proper books of account of all income and expenditure of the Trust and shall prepare an income and expenditure account and balance sheet as on 31st day of March every succeeding English Calendar year. The accounts of every year shall be audited by an auditor who shall be appointed by the Trust for the purpose.

14. CUSTODY OF DOCUMENTS:

The Managing Trustee or his nominees or any other Trustee authorized by the Managing Trustee shall have the custody of all deeds and documents of title relating to the Trust properties and investments and books of account and other records relating to the Trust.

15. ADVISORY BOARD:

The Founder and Trustees may maintain a list of advisors for better administration of any particular objects by engaging their services. The trustees shall have liberty to fix remuneration for the services rendered by the advisors.

16. GENERAL FUNCTION:

- a) This Trust is irrevocable. If the Trust hereby constituted fails for any reason in the option of the Founder Trustee, the net assets of the Trust both movable and immovable shall be handed over to any individual or agency or any public charitable Trust.
- b) The funds of the Trust would not be used for any religious purposes or given to religious institutions.
- c) The benefits of the Trust are open to all in the Society at large irrespective of caste, creed, religion, sex, etc.
- d) The Managing Trustee and the Trustees may frame additional rules and regulations as and when need arises for the proper administration and functioning of the Trust.
- e) As such the Trust have no movable or immovable properties.
